2. The organisation

The World Rural Forum (WRF) is a plural network promoting Family Farming and Sustainable Rural Development.

The WRF develops an intense activity aimed at promoting political dialogue and contributing to differentiated public policies for Family Farming. The WRF carries out recognised international advocacy work, through alliances and networks, while promoting the actions of its partner organisations in countries and regions.

The activities can be broken down as follows:

- Promotion of articulation, political dialogue and construction spaces between multiple actors, at national, regional and international levels.
- Strengthening the capacities of family farming organisations.





- Events, exchanges and knowledge management between different actors from the 5 continents.
- Promotion and strengthening of alliances with key actors.
- Technical support for public policy.

The WRF brings together organisations representing more than 35 million family farmers on 5 continents. In addition, it maintains partnerships with hundreds of external (non-member) organisations around the world.

3. Project description

The project is being implemented in collaboration with 6 other partners and members of the World Rural Forum:

- The Plateforme Régionale d'Organisations Paysannes d'Afrique Centrale (PROPAC) based in Cameroon
- The Pacific Island Farmers Organisation Network (PIFON) based in Fiji

Target groups

 advancing the 2030 Agenda, particularly in the areas of democracy, equitable rural
 development, family farming and food systems transformation and climate change.

4. Purpose and objectives of the baseline study

The purpose of the baseline study is to assess and improve the project Monitoring and Evaluation system to ensure its efficacy and relevance with the EU criteria and processes. It will also provide clear guidelines and tools for the project teams and partners on how to ensure quality and timely data collection, reporting and monitoring of the activities' results and evaluation. The Consultant or Consulting Agency will be responsible for:

- Analysing the indicators outlined in the project logical framework with regard to the expected results and impact of the project and offering suggestions for improvement.
- Suggesting new results and impact indicators to be included in the logical framework based on the Core indicators for design and monitoring of EU-funded interventions.
- Designing the monitoring and evaluation processes to ensure efficient data collection and analysis.
- Supporting the design of tools to monitor the achievement of the project results for each implementing partner as well as for the overall project.
- Assessing the quality of the encoding of the project indicators in the European Commission online platform OPSYS and providing guidelines for reporting the project progress and results through the EU platform.
- Ensure all relevant indicators are disaggregated by gender, age, region or any other relevant subcategory.

More areas of support may be identified by the consultant as a result of the study of the project's logical framework and discussions with the project team.

5. Methodology and approach

The Consultant or Consulting Agency is tasked with crafting a methodology that considers the details provided in the Terms of Reference (ToRs), ensuring precision and thoroughness. The Consultant or Consulting Agency will develop a work plan that will be reviewed by the WRF team. The plan will indicate and explain the methods, techniques, and processes of data collection and analysis in the inception report submitted by the consultant at the beginning of the contract.
